

Government Incentives

FISCAL INCENTIVES PROGRAMS

Grants the incentive holder exemptions from Customs Duty, Revenue
Replacement Duty and Excise Duty on imports under the eligible categories.

One-Off Fiscal Incentive

Up to one million dollars on capital investments in the approved activity.

Not more than one year, on not more than one occasion in any calendar year to the same enterprise.

MSME Fiscal Incentive

Up to one million dollars, for up to four years.

With an option to renew for a further period of up to four years, in any case up to a maximum of 8 years.

Regular Fiscal Incentive

Up to a period of five years with an option to renew for an additional five years.

In any case up to a maximum of twenty- five years.

Government Incentives

DESIGNATED PROCESSING AREAS PROGRAMS

• The Designated Processing Area (DPA) Program is intended to support investments that engage in international trade and value addition inclusive of technology transfer, generation of employment, and production according to standards of the intended market.

DPA Developer

Provides a space to be occupied solely by DPA Businesses that engage in approved activities.

Provides all relevant infrastructure, facilities, utilities and services necessary to support approved activities within the DPA.

DPA Business

The Company must have an agreement with a DPA Developer to operate within that DPA, that is administered by the DPA Developer.

Special DPA

An enterprise that conducts only approved activities and holds the status of a DPA.
